

ADNOC Distribution's Q1 progress follows sustained momentum in both fuel and non-fuel retail segments

Adnoc Distribution reports robust Q1 financial results

In Q1, the company's EBITDA increased by 18% Y-o-Y to \$248m, with net profit reaching \$150m compared to \$146m in Q1 2023

Adnoc Distribution announced robust Q1 financial results, reporting an 18% year-on-year increase in its Earnings Before Interest, Taxes, Depreciation and Amortisation (EBITDA) to \$248 million, demonstrating that the company remains firmly on track to achieving the goals outlined in its new five-year strategy.

The progress follows sustained momentum in both fuel and non-fuel retail segments in Q1, including developments in Adnoc Distribution's pipeline of more than 20 Artificial Intelligence (AI)-driven initiatives, such as Fill and Go and the Fuel Demand AI Model, aimed at accelerating growth and enhancing operational efficiencies.



Adnoc Distribution's total fuel volumes increased by 17% year-on-year, driven by growth in both retail and commercial segments —WAM

to achieve our operational objectives for 2028, aiming to expand the Adnoc Distribution network to 1,000 stations, increase the number of fast and super-fast EV charging points to at least 500, grow our non-fuel transactions by 50%, and increase the number of convenience stores by 25%."

He added that the integration of AI continues to demonstrate tangible benefits across Adnoc Distribution operations. "For instance, thanks to our innovative Fuel Demand AI Model, we harness predictive demand analytics to optimise fuel delivery across our network. The model is projected to prevent potential lost sales totalling over \$27 million in a five-year period."

The company reported a double-digit increase in EBITDA compared to the same period last year, with higher traffic across its network driving growth in fuel volumes and non-fuel business.

In Q1, Adnoc Distribution's EBITDA increased by 18% year-on-year to \$248 million, with net profit reaching \$150 million com-

With planned capital expenditures of between \$250 million and \$300 million in 2024, 70% of which are earmarked for growth, the company has already invested \$46 million in Q1

pared to \$146 million in Q1 2023, despite the impact of the recently introduced UAE Corporate Tax. Excluding the tax impact, net profit saw a robust 13% year-on-year increase to \$165 million.

The company also reported a strong non-fuel gross profit increase of 16% year-on-year to \$55 million. Adnoc Distribution maintained a strong balance sheet with a net debt-to-EBITDA ratio of 0.50x, reinforcing its strong financial position and enabling the company to invest in growth and deliver attractive shareholder returns.

Operational highlights for the quarter include sustained growth in fuel volumes in all regions where the company operates. Total fuel volumes increased by 17% year-on-

year, driven by growth in both retail and commercial segments.

The GCC region saw a 9% increase, fueled by increased traffic across the company's network, sustained economic growth, ongoing network expansion, and a higher contribution from international operations in Saudi Arabia.

In Q1, Adnoc Distribution opened eight new service stations, expanding its total network to 846 stations. The company remains on track to achieve its full-year target of adding between 15 and 20 new sites.

Adnoc Distribution also saw ongoing growth in its non-fuel retail business, with transactions increasing by 7% across the network in the UAE.

Abu Dhabi Judiciary settles 61.3% of family disputes amicably in 2023

Moreover, the department's diverse awareness campaigns and initiatives have played a pivotal role in achieving high rates of amicable settlements. For instance, the "Reconciliation is Good" campaign conducted 47 family awareness workshops last year, positively impacting approximately 4,000 individuals.

First wind turbine installed at Baltic Eagle offshore wind farm

ABU DHABI / WAM



The first of a total of 50 wind turbines has been successfully installed at the 476MW Baltic Eagle offshore wind farm, a joint venture between Abu Dhabi Future Energy Company - Masdar, the UAE's clean energy powerhouse, and Iberdrola, a world-leading clean energy company. Working in partnership with Vestas, the remaining wind turbines will be transported to the offshore construction site in the coming months and installed using the jack-up vessel Blue Tern owned by "Fred. Olsen Windcarrier."

Baltic Eagle is on track to become operational by the end of 2024, when it will supply renewable energy to around 475,000 households and contribute to Germany's clean energy transition. "With the installation of its

first wind turbine, Baltic Eagle is taking shape off the German Baltic coast. This marks the start of the final phase in the construction of the offshore wind farm, which is expected to become fully operational later this year," commented Felipe Montero, CEO of Iberdrola Deutschland.

The Baltic Eagle offshore wind farm will generate its green electricity from a total of 50 Vestas V174-9.5MW wind turbines, each with an output of 9.525 megawatts (MW). The wind turbines have a rotor diameter of 174 metres and a hub height of 107 metres.







CEPAs play key role in surging FDI inflows to UAE: Adio official

Abu Dhabi Investment Office offers incentives for greenfield projects facilitating connections to talent pools, and ensuring access to financing: Massimo Falcioni

ABU DHABI/ WAM

The UAE is attracting an increasing flow of foreign direct investment (FDI), driven by several factors, among which a network of Comprehensive Economic Partnership Agreements (CEPAs) with global partners is particularly significant, according to Massimo Falcioni, Chief Competitiveness Officer (CCO) at Abu Dhabi Investment Office (ADIO).

The UAE's strategic location, focus on digitalisation and future-oriented industries also complement this favourable trend, he said in an interview with the *Emirates News Agency (WAM)* during the ongoing AIM Congress at the Abu Dhabi National Exhibition Centre (ADNEC).

The COO stressed that CEPAs play a crucial role in making the UAE an attractive destination for businesses. "CEPAs are highways for goods and services to countries [that have signed agreements with the UAE]."

PASSPORT TO WIDER MARKETS

These agreements act as a "passport" for foreign businesses, granting them access to a wider market for their goods and services, reducing trade barriers, simplifying customs procedures, and streamlining supply chains, he explained.

"This makes the UAE an attractive launchpad for companies seeking to expand globally," Falcioni said.

FDI INFLOWS TO UAE

The Adio executive referenced the World Investment Report 2023 of the United Nations Council on Trade and Development (UNCTAD), which valued the FDI inflows to the UAE in 2022 at \$22.737 billion (AED 83.5 billion), up by 10 per cent or \$2.07

billion (AED 7.6 billion), to rank 16th globally in FDI inflows.

The UAE was ranked first in the West Asia region since it received 47.1 percent of the total FDI inflows to the region, amounting to \$48.3 billion.

The UAE also was ranked 1st in the Mena region as it accounted for 32.4 percent of the total FDI inflows to the region, amounting to \$70.2 billion.

Falcioni highlighted the UAE's

FDI TO GREENFIELD PROJECTS

A particular focus for UAE is attracting FDI into greenfield projects — entirely new ventures, the executive said. The Abu Dhabi Investment Office offers incentives for such projects, including access to land at competitive rates, facilitating connections to talent pools, and ensuring easy access to financing, he added.
