A major highlight was the group's progress in decarbonisation. In 2023, the group reduced the environmental intensity of container port handling operations through efficiency gains, energy savings and decarbonisation efforts. Its greenhouse gas (GHG) emission intensity, an industry measure of the environmental impact of industrial

activity, fell by 2%, in 2023 to 11.67 kilograms of carbon dioxide equivalent per TEU (Twenty Foot Equivalent Unit) (kgCO2e per TEU) in 2023 from 11.93 kgC02e per TEU in 2022.

The reductions were achieved through greater efficiency within the group's container handling operations, more energy savings at its terminals, and ongoing decarbonisation efforts such as the increased use of electricity from solar photovoltaic (PV) units. The 2023 Sustainability Report reported a 7% reduction in electricity consumption intensity. The improvements were amongst a broader set of sustainability gains that also included a 174% increase in the quantity of solid waste that was recycled.

The solar PV electric generating capacity integrated into its 2023 operations has contributed to a reduction of 5,000 tonnes of CO2 equivalent using clean energy. The group has solar PV integration projects planned at Khalifa Port, Zayed Port and its administrative headquarters in Abu Dhabi, and at a multipurpose port operation in Safaga, Egypt, which the group manages under a concession for Egypt's Red Sea Ports Authority.






