

Hotel revenues in Abu Dhabi reach AED847 million in April 2025

Hotel establishments in Abu Dhabi generated revenues amounting to AED847 million in April 2025, comprising AED540 million from rooms, AED256 million from food and beverage, and AED51 million from other services.

According to preliminary data released by the Department of Culture and Tourism – Abu Dhabi and issued by the Statistics Centre – Abu Dhabi, hotels across the emirate welcomed approximately 531,000 guests in March 2025.

The figures underscore Abu Dhabi's growing appeal as a global tourism destination, supported by a diverse range of accommodation options and elevated serv-


