If amicable settlement fails, one of the parties shall resort to commercial arbitration in accordance with the procedures of the Arbitration Center at the Abu Dhabi Chamber of Commerce and Industry. The arbitration decision shall be binding on the parties and shall have the force of an enforceable instrument, in accordance with Article 73 of the Companies Law.

5. This notice of meeting shall be communicated to the parties, shall posted at the company's headquarters, shall be published in a local newspaper in Abu Dhabi, and shall be sent to the remaining parties via email and WhatsApp.
