



UAE aid ship 'Khalifa' arrives in Al Arish Port in Egypt

The eighth UAE aid ship, Khalifa, reached Al Arish Port in Egypt on Tuesday as part of "Operation Chivalrous Knight 3," in preparation for delivering its cargo to the Gaza Strip, in continuation of the UAE's humanitarian support for the Palestinian people.

The ship was received by a delegation of representatives from humanitarian and charitable organisations, along with Ahmed Sari Al Mazrouei, Secretary-General of the Emirates Red Crescent (ERC), and Egyptian officials.

The arrival of the Khalifa aid ship underscores the UAE's steadfast commitment to delivering humanitarian



and relief aid to the Palestinian people, especially amid the escalating humanitarian challenges in the Gaza Strip. Departing from Khalifa Port in Abu Dhabi, the ship was loaded with 7,166 tonnes of humanitarian assistance, including food, medicines, medical supplies, relief items, dates and shelter materials, for the Palestinian people in the Gaza Strip.

Comprising 4,372 tonnes of food, 1,433 tonnes of shelter supplies, 860 tonnes of medical materials, and 501 tonnes of health items, the shipment brings the overall aid dispatched to the Gaza Strip to more than 80,000 tonnes.

UAE: Unfounded allegations by Port Sudan Authority are baseless PR stunts to justify impeding peace efforts

The United Arab Emirates categorically rejects the false and unfounded allegations made in the statement issued by the Port Sudan Authority, which inaccurately claims the UAE's involvement in the ongoing civil conflict in Sudan through alleged support for armed groups or

factions.

The UAE affirms that these baseless allegations, entirely devoid of evidence, are nothing more than feeble media stunts aimed at diverting attention from the Port Sudan Authority's direct responsibility for prolonging the civil war that has lasted for over two years and for obstructing all regional and international efforts to achieve peace in Sudan.

International mechanisms have confirmed this, including the ruling by the International Court of Justice in The Hague, which dismissed the legal proceedings brought by the Port

The UAE reiterates that the so-called Port Sudan Authority does not represent the legitimate government of Sudan, nor (does)it reflect the will of its honourable people

Sudan Authority against the UAE, as well as the final report of the Panel of Experts on Sudan, released on April 17, 2025, which presented no findings or evidence against the UAE. These authoritative conclusions confirm that the Authority's repeated allegations are baseless and lack any legal or factual basis. The UAE reiterates that the so-called Port Sudan Authority does not represent the legitimate government of Sudan, nor (does)it reflect the will of its honourable people.

bu Dhabi Art has revealed the artists participating in the 2025 edition of Beyond Emerging Artists the annual programme which commissions new work by up-and-coming UAE-based artists to exhibit at the fair each year.

This year's edition will be curated by internationally renowned artist Issam Kourbaj, who has selected Alla Abdunabi, Salmah Almansoori and Maktoum Marwan Al Maktoum as the three participants invited to develop new commissions to be exhibited at the Abu Dhabi Art Fair, which will take place from 19 to 23 November 2025 at Manarat Al Saadiyat. The new works will also be exhibited internationally after the fair ends. The annual Beyond Emerging Artists programme seeks to provide emerging UAE-based artists with opportunities to develop their work, benefit from the mentorship programme provided by the guest curator each year and reach new audiences through the platform of the fair.



The selected artists share practices that span installation, sculpture and conceptual storytelling, exploring themes of identity, memory, materiality and the layered histories of place. Issam Kourbaj commented on their selection: "It was challenging to select just three participants for the programme, from amongst so many exciting emerging artists put forward. Like many creatives around the world, young artists in the region are directing their gaze toward excavating the present and engaging with urgent matters of our time, whether environmental, social, or historical. I very much look forward to working with the three selected artists—Alla Abdunabi, Salmah Almansoori, and Maktoum Marwan Al Maktoum—and guiding their visual voices as they develop a body of work inspired by Al Ain, both as a source and a canvas for new ideas."



Alla Abdunabi is a visual artist working in sculpture and installation. Her practice explores the afterlives of objects through storytelling that merges historical, personal, and fictional narratives. She reflects on shifting histories and the material memory of place.

"I'm honoured to be part of Beyond Emerging Artists this year," said Abdunabi. "With the support of Abu Dhabi Art and curated by Issam Kourbaj, I'll be exploring object histories in my presentation at the fair. In addition, through the Al Ain commission, I look forward to creating a site-specific work that listens to the buried histories of the land"

Maktoum Marwan Al Maktoum is a multidisciplinary artist whose work explores the human condition through themes such as value, time, belief systems and the psyche. His practice is influenced by lived experience, folklore, storytelling, surrealism, language and metaphor. Through a narrative-driven, world-building approach, he constructs new associations and meanings that reflect cultural memory and personal exploration.



"I am honoured to have been selected as part of the Beyond Emerging Artists programme," he said. "I especially look forward to the mentorship of Issam Kourbaj and continuing the world-building approach of my work within the context of an art fair, as

sites such as the ones found in Al Ain."

Salmah Almansoori is a multidisciplinary artist, whose practice spans painting, sculpture, and installation. Rooted in personal memory and the overlooked details of her hometown, her work documents what is being erased—abandoned places, forgotten objects, and fading traditions. By collecting fragments from these sites and transforming them into abstract yet intimate narratives, she explores themes of displacement, identity, and emotional inheritance.

"I'm grateful to be part of Beyond Emerging Artists this year. This opportunity allows me to deepen my exploration of memory and place, and to share stories from my hometown that are often overlooked. With the guidance of Issam Kourbaj, I look forward to developing a new body of work that reflects on transformation, loss, and belonging." said Almansoori.


BEYOND EMERGING ARTISTS (BEA) 2024 EXHIBITION IN HONG KONG

Based on our performance to date and a positive outlook, we expect the annual traffic to reach 96 million this year, bringing us closer to the symbolic 100 million milestone."

PERFORMANCE & EFFICIENCY

Average monthly traffic in H1 stood at approximately 7.7 million, with daily volumes averaging 254,000. January was the busiest month of the period and also set a new monthly record, with 8.5 million guests.

DXB handled 222,000 total flights during the first half of the year, while the load factor reached 76%. A total of 41.8 million bags were processed, with 91% delivered within 45 minutes on arrival. The mishandled baggage rate remained low at just 2 bags per 1,000 guests, significantly outperforming the 2024 industry average of 6.3 reported by SITA. The airport is on track to process over 85 million bags by year-end, surpassing its previous record of 81.2 million set in 2024. The busiest baggage days were between January 3-5, with daily volumes reaching 300,000

Efficiency at key guest touchpoints also remained consistently high. In the first half, 99.2% of guests cleared departure passport control in under 10 minutes, 98.4% cleared arrivals in under 15 minutes, and 98.7% passed through security checks in under 5 minutes. *


