He was received by Dr. Abdulla Al Mandous, Director-General of the Centre and President of the World Meteorological Organisation (WMO), along with several senior officials.

During the visit, HH Sheikh Mansour was briefed on the NCM's advanced infrastructure and modern meteorological technologies. He toured the Operations Centre, weather forecasting units, cloud seeding systems, marine monitoring units, and renewable energy weather forecasting sections. He was also updated on the latest developments in international joint research related to the Antarctic.

HH Sheikh Mansour also listened to a detailed explanation of the numerical weather prediction systems, which rely on a state-of-theart supercomputer—one of the most advanced in the region—used for climate data analysis to enhance forecasting accuracy and improve early warning readiness.

Sheikh Mansour also visited the NCM's Media Affairs Unit, where he was introduced to a range of digital applications and platforms developed by the NCM to serve both local and international communities. These services include direct alert systems during weather events, interactive maps, and smart applications that provide real-time weather information to various segments of society, thereby fostering a culture of preparedness and responsiveness.
