

The latest data released by the Statistical Centre for the Cooperation Council for the Arab Countries of the Gulf (GCC-Stat) revealed that the economies of the Gulf Cooperation Council (GCC) countries recorded positive growth during the first quarter of 2025, reflecting the continued economic stability and sustainable development path in the region.

The report indicated that the nominal GDP of the GCC countries amounted to around US\$588.1 billion, up by 5.7 percent compared to the first quarter of 2024. The real GDP reached US\$466.2 billion, recording an annual growth rate of

3.0 percent. The report showed that all GCC economies recorded positive growth rates in the first quarter of 2025 compared to the same period last year.
