







# UAE President receives phone call from UK Prime Minister

UAE President His Highness Sheikh Mohamed bin Zayed Al Nahyan received a phone call on Monday from the Rt Hon Sir Keir Starmer, Prime Minister of the United Kingdom.

The call discussed ways to enhance cooperation between the two countries in support of their mutual interests

Both sides reaffirmed their com-

mitment to continued collaboration and to building on the longstanding relationship between the UAE and the UK to promote prosperity for both peoples and advance peace and stability across the Middle East and the wider world.

holding the ceasefire and ensuring the sustained, unobstructed delivery of sufficient humanitarian aid to alleviate the suffering of civilians.
