EAD achieves 100% Sustainable Fisheries Index milestone in 2025

The achievement reflects the effectiveness of Abu Dhabi’s approach to restoring marine resources through scientific policies, habitat protection

ABU DHABI / WAM

Environment Agency – Abu Dhabi (EAD) has recorded a significant increase in its Sustainable Fisheries Index, reaching 100 percent by the end of 2025, up from 8 percent in 2018.

The achievement reflects the effectiveness of Abu Dhabi’s approach to restoring marine resources through scientific policies, habitat protection and the development of a sustainable system to enhance fish stock abundance.

The progress reflects Abu Dhabi’s environmental management model and its ability to rebuild fish stocks in line with the highest international standards.

The Syrian–Emirati Medical Readiness Forum concluded in Damascus under the patronage of the Syrian Ministry of Health, with the participation of more than 200 medical, nursing, paramedical and technical professionals from hospitals affiliated with the Ministries of Health and Higher Education, as well as the Police.


The forum was held within a strategic plan to train 10,000 healthcare workers in Syrian hospitals over five years, based on a unified, internationally accredited curriculum. Organised by the Jaheziya Syria Program and Al Wataniya for Training (Tadreeb), and accredited by the European Centre for Disaster Medicine, the three-day forum took place at Damascus Hospital.

It featured training lectures, workshops, tabletop exercises and live simulations reflecting real-life

During the forum, the establishment of accredited medical training centres specialising in emergency medicine, disaster medicine and crisis management was announced at the Syrian Board of Medical Specialties, Damascus Hospital and the Field Hospital

scenarios, aimed at strengthening hospital readiness and enhancing emergency and disaster response capabilities.

The centres are fully equipped with audiovisual systems and medical training tools, marking a first-of-its-kind initiative to build medical readiness in line with international best practices.


