

UAE President and Iraqi President discuss regional developments and implications in phone call

ABU DHABI / WAM

UAE President His Highness Sheikh Mohamed bin Zayed Al Nahyan on Sunday received a phone call from His Excellency Dr Abdul Latif Rashid, President of the Republic of Iraq, during which they discussed the serious military escalation in the region and its repercussions for regional security and stability, in addition to the blatant Iranian attacks on the territory of the UAE and a number of other countries.

Both sides underscored the importance of intensifying international efforts to halt the military escalation while pursuing political solutions in a way that safeguards regional peace and security and prevents the conflict from widening

During the call, the Iraqi President expressed his country's solidarity with the UAE following the attacks on its territory. His Highness thanked His Excellency Rashid for Iraq's supportive stance towards the UAE.

Both sides underscored the importance of intensifying international efforts to halt the military escalation while pursuing political solutions in a way that safeguards regional peace and security and prevents the conflict from widening.

UAE air defences intercept 165 ballistic, two cruise missiles, 541 drones since onset of Iranian attack

ABU DHABI / WAM

The Ministry of Defence has announced that the UAE air force and air defence forces have so far dealt with 165 ballistic missiles, two cruise missiles and 541 Iranian drones since the start of the Iranian attack.

The ministry said that on the morning of the second day of the attack, UAE air force and air defence forces destroyed 20 ballistic missiles, while eight missiles fell into the sea. They also destroyed two cruise missiles and 311 drones. However, 21 drones struck civilian targets. The ministry affirmed the capability of the UAE air force and air defence to address various threats.

A total of 541 Iranian drones were detected, of which 506 were intercepted and destroyed, while 35 fell within the country, causing material damage. It resulted in three fatalities of Pakistani, Nepali and Bangladeshi nationalities, and 58 minor injuries among Emirati, Egyptian, Ethiopian, Filipino, Pakistani, Iranian, Indian, Bangladeshi, Sri Lankan, Azerbaijani, Yemeni, Ugandan, Eritrean, Lebanese, Afghan nationals

UAE announces closure of Embassy in Tehran, withdrawal of Ambassador and diplomatic mission, condemns Iranian missile attacks

ABU DHABI / WAM

The United Arab Emirates has announced the closure of its Embassy in Tehran and the withdrawal of its Ambassador to the Islamic Republic of Iran, along with all members of its diplomatic mission, in response to the blatant Iranian missile attacks that targeted the UAE's territory.

These hostile attacks against civilian sites, including residential areas, airports, ports, and service facilities, endangered innocent civilians in a serious and irresponsible escalation and constitute a flagrant violation of national sovereignty, as

well as a clear breach of international law and the Charter of the United Nations.

The Ministry of Foreign Affairs (MoFA) affirmed that this decision reflects the UAE's firm and unwavering stance against any aggression that threatens its security and sovereignty. It comes in light of continued hostile and provocative conduct that undermines de-escalation efforts and pushes the region toward a highly dangerous trajectory, threatening regional and international peace and stability, as well as energy security and the stability of the global economy.

The Authority confirms that it will continue to closely monitor developments in the region and assess the situation on an ongoing basis, taking any further measures as necessary.

Senior delegation from Abu Dhabi visits Sheikh Shakhbout Medical City to assure patients affected by regional incidents, reaffirming readiness of integrated healthcare system

A senior delegation from Abu Dhabi has visited the Sheikh Shakhbout Medical City (SSMC) to check on the condition of individuals injured due to the regional events and reviewed the level of treatment services being provided to them.

The delegation included Major General Ahmed Saif bin Zaitoon Al Muhairi, Commander-in-Chief of Abu Dhabi Police and Chairman of the Emergency, Crisis and Disaster Management Team for Abu Dhabi; Mansoor Ibrahim Al Mansoori, Chairman of the Department of Health - Abu Dhabi; Dr Noura Khamis Al Ghaithi, Undersecretary of the Department of Health - Abu Dhabi; Matar Saeed Al Nuaimi, Director General of the Emergency, Crisis and Disaster Management Centre - Abu Dhabi, and Dr. Rashed Alsuwaidi, Director General of the Abu Dhabi Public Health Centre.

During the visit, the delegation received detailed briefings from

medical staff on the cases admitted, approved treatment plans, and coordination mechanisms between healthcare facilities and relevant entities within an integrated response system that ensures rapid intervention and efficient care.

The delegation has also highlighted the strong integration of

medical and specialised teams, as well as the advanced clinical and technical capabilities that support the management of various cases according to the highest standards of professionalism.

The delegation affirmed that the emirate's healthcare sector is operating at full capacity, supported by clear emergency re-

sponse protocols and an effective coordination framework among health, security, and service entities, the matter that reflects the advanced level of preparedness and the ability to deal with any cases and provide comprehensive care without interrupting the continuity of normal healthcare services.

Ministry of Defence responds to targeting of Al Salam military base

The Ministry of Defence has announced that specialised teams on Sunday responded to an incident resulting from the targeting of a warehouse at Al Salam naval base in Abu Dhabi by two Iranian drones, leading to a fire in two containers storing general materials, with no casualties reported.

The ministry strongly condemned the military targeting, describing it as a blatant act of aggression and a flagrant violation of national sovereignty and international law.

It affirmed that the UAE reserves its full right to respond to this escalation and to take all necessary measures to protect its territory, people and residents, in a manner that safeguards its sovereignty, security and stability

UAE strengthens its position as global hub for aircraft maintenance and repair

The nation has established itself as an integrated global destination for MRO services

The UAE is further consolidating its standing as a leading regional and global centre for aircraft maintenance, repair and overhaul (MRO), supported by its status as a major aviation market and as home to large and expanding fleets operated by national carriers with a strong international presence.

The UAE ranks among the largest aviation markets in the region, driven by major national airlines including Emirates, Etihad Airways, flydubai and Air Arabia, which collectively operate hundreds of modern aircraft and serve tens of millions of passengers annually.

This generates sustained and growing demand for maintenance, repair and upgrade services within the country.

Beyond its domestic and regional standing, the UAE has established itself as an integrated global destination for MRO services, attracting airlines and service providers from across continents and exporting technical and engineering services to international markets.

In 2025, specialised zones such as Dubai South and the Mohammed bin Rashid Aerospace Hub recorded significant developments that further strengthened

the country's stature in the sector.

These included attracting regional and international companies specialising in maintenance services, technical support and aircraft equipment, alongside expansion in the construction of advanced hangars and heavy maintenance facilities.

During 2025, the Mohammed bin Rashid Aerospace Hub signed strategic agreements with a select group of global companies, including Avia Solutions Group (ASG), the world's largest ACMI (Aircraft, Crew, Maintenance and Insurance) provider; Atherion Aerospace, an aerospace manufacturing venture and a subsidiary of Economic Group Hold-

ings (EGH); UUDS, a leader in the business aviation industry; Tariq Al Futtaim Group and Al Burj Holding.

The Mohammed bin Rashid Aerospace Hub also announced the launch of new facilities aimed at attracting leading global airlines and luxury retail brands.

According to a report by BlueWeave Consulting, the UAE's aircraft MRO market was valued at approximately US\$3.06 billion in 2025, with a projected compound annual growth rate of around 5.09 percent, reaching an estimated US\$4.33 billion by 2032, driven by fleet expansion and increased commercial air traffic.

The Authority stated that the country's airports and national carriers are working in an integrated manner to manage operational traffic in accordance with approved plans. Measures implemented include the rerouting of certain flights between the country's airports, the acceleration of rescheduling processes, and the strengthening of on-ground coordination within passenger terminals to address any potential congestion.
