## UAE President receives phone call from Spanish Prime Minister condemning Iranian attacks

UAE President His Highness Sheikh Mohamed bin Zayed Al Nahyan on Monday received a phone call from His Excellency Pedro Sánchez, Prime Minister of the Kingdom of Spain, to discuss the serious military and security developments in the region amid the ongoing escalation and its implications for regional and international peace and security.

His Excellency Sánchez condemned the blatant Iranian attacks targeting the UAE and other countries in the region,

Both sides called for an immediate halt to military escalation and a return to dialogue and political solutions, stressing that the continuation and expansion of the conflict would threaten peace and stability in the region and beyond

noting that Spain's Ministry of Foreign Affairs had summoned the Iranian ambassador in Madrid to convey its rejection and condemnation of the attacks.

His Highness thanked His Excellency Sánchez for Spain's supportive stance towards the UAE.

Both sides called for an immediate halt to military escalation and a return to dialogue and political solutions, stressing that the continuation and expansion of the conflict would threaten peace and stability in the region and beyond.

## S&P affirms UAE 'AA/A-1+' ratings with stable outlook

ABU DHABI / WAM

S&P Global Ratings affirmed its 'AA/A-1+' long- and short-term foreign and local currency sovereign credit ratings on the UAE with stable outlook.


The stable outlook reflects the agency's view that the UAE's large fiscal and external buffers should provide space for policy maneuvering during adverse geopolitical developments or unfavorable hydrocarbon sector dynamics, including disruption in oil production or exports, said the agency in its latest rating on the UAE. "Our ratings on the UAE remain supported by the government's strong fiscal and external positions. Our estimate of the exceptional strength of the government's consolidated net asset position (estimated at 184% of GDP in 2026) provides a significant fiscal external and economic buffer to external shocks. We calculate government liquid assets at about 210% of GDP"

The UAE's general government debt is very low (estimated at about 27% of GDP in 2026) and its consolidated fiscal balance has averaged a surplus of 5.6% over 2021-2025: S&P Global Ratings

"The UAE's general government debt is very low (estimated at about 27% of GDP in 2026) and its consolidated fiscal balance has averaged a surplus of 5.6% over 2021-2025," the agency added.

Non-oil sectors, it said, constitute about 75% of GDP and this enhances the economy's ability to withstand the volatility of global markets, in addition to the role played by government investments and sovereign wealth funds in supporting financial stability.

## GCC records strong agri, livestock, fisheries performance in 2024

Vegetables ranked first among plant products by volume, accounting for 45.8% of total GCC crop production

The Gulf Cooperation Council (GCC) countries recorded strong performance in the agriculture, livestock and fisheries sectors during 2024, reflecting the growing role of these sectors in supporting food security and advancing economic diversification across the GCC, despite the environmental and natural challenges facing the region, particularly limited arable land and scarce water resources.

Data released by the Statistical Centre for the Cooperation Council for the Arab Countries of the Gulf showed that the contribution of the agriculture and fishing sector to gross domestic product at current prices reached around \$40 billion in 2024, registering a 5.1 percent increase compared with 2023, while the sector's share of the GCC's gross domestic product remained stable at 1.7 percent.

Data released by the Statistical Centre for the Cooperation Council for the Arab Countries of the Gulf showed that the contribution of the agriculture and fishing sector to gross domestic product at current prices reached around \$40 billion in 2024, registering a 5.1 percent increase compared with 2023, while the sector's share of the GCC's gross domestic product remained stable at 1.7 percent

With regard to intra-GCC trade, intra-regional exports of agricultural products among GCC countries reached around \$4.8 billion in 2024, compared with \$4.5 billion in 2023, representing growth of 7.2 percent

Total GCC crop production reached around 12.7 million

tonnes in 2024, up 3.9 percent from around 12.2 million tonnes in 2023, while total livestock in the GCC stood at

around 42.5 million head, recording 3.6 percent growth compared with the previous year.

Vegetables ranked first among plant products by volume, accounting for 45.8 percent of total GCC crop production, underscoring their central role in the GCC's food production structure.

Meanwhile, sheep maintained their leading position in GCC livestock, accounting for 60.5 percent of total livestock across the GCC, with a total of 25.7 million head, followed by goats at around 12.5 million head, camels at 3.2 million head, and cattle at around 1.2 million head.
