

## UAE air defences intercept 8 ballistic missiles, 26 UAVs

Launched in Cherbourg, France, the FOC BR71 MK II vessel was designed and constructed by CMN, a world-renowned naval shipbuilding group specialising in the design, engineering, and construction of naval and commercial vessels, and mega yachts.

The UASs will be fully integrated with the vessels' combat management systems.

Ishan Sahgal, Founder and Co-CEO of ANAVIA, said, "We are delivering a proven force multiplier for maritime surveillance to the Angolan Navy. In addition to the advanced performance and reliability of

the HT-100, we are also providing a custom-made control station and integrated logistics support and training."

The second BR71 MK II Combattante is under construction by ADSB in Abu Dhabi, UAE, and

the third is being built by CMN NAVAL in Cherbourg, France.
