

UAE President His Highness Sheikh Mohamed bin Zayed Al Nahyan on Monday received His Majesty King Abdullah II bin Al Hussein of the Hashemite Kingdom of Jordan.

The meeting was attended by His Highness Sheikh Mohammed bin Rashid Al Maktoum, Vice President, Prime Minister and Ruler of Dubai, and His Highness Sheikh Mansour bin Zayed Al Nahyan, Vice President, Deputy Prime Minister, and Chairman of the Presidential Court.

His Highness Sheikh Mohamed bin Zayed and His Majesty King Abdullah II, who is on a fraternal visit to the UAE, exchanged greetings and best wishes ahead of Eid Al-Fitr, wishing continued wellbeing, prosperity, and stability for their countries and peoples.

During the meeting, His Highness and the King of Jordan discussed re-

gional developments in light of the escalating military situation and the serious implications it poses for security and stability in the region.

The meeting also addressed the continued Iranian aggression targeting countries in the region, which constitutes a violation of sovereignty and international law and norms and represents a threat to international peace and security.

In this context, His Majesty King Abdullah II reaffirmed Jordan's solidarity with the UAE regarding all measures it is taking to defend its sovereignty and security and ensure the safety of its people.

His Highness Sheikh Mohamed bin Zayed also affirmed the UAE's solidarity with Jordan in confronting the Iranian attacks targeting its sovereignty and security.

UAE air defences engage 6 ballistic missiles, 21 UAVs

ABU DHABI / WAM

The UAE air defence systems on 16th March 2026 engaged six ballistic missiles and 21 UAVs launched from Iran.

Since the onset of the blatant Iranian aggression, UAE air defences have engaged 304 ballistic missiles, 15 cruise missiles and 1,627 UAVs.

These attacks have resulted in the martyrdom of two members of the armed forces while performing their national duty, as well as five fatalities of Pakistani, Nepali, Bangladeshi and Palestinian nationalities.

A total of 145 people were also injured, with injuries ranging from minor to moder-



ate and severe. The injured included nationals of the UAE, Egypt, Sudan, Ethiopia, the Philippines, Pakistan, Iran, India, Bangladesh, Sri Lanka, Azerbaijan, Yemen, Uganda, Eritrea, Lebanon, Afghanistan, Bahrain, Comoros, Türkiye, Iraq, Nepal, Nigeria, Oman, Jordan, Palestine, Ghana, Indonesia and Sweden.

The Ministry of Defence affirmed that it remains fully prepared and ready to deal with any threats, and will firmly confront any attempts to undermine State security in a manner that ensures the protection of its sovereignty, security and stability, and safeguards its national interests and capabilities.

ADAFSA receives 39,000 trainees via food safety programme in 2025

The Abu Dhabi Agriculture and Food Safety Authority (ADAFSA) recorded significant milestones in its Essential Food Safety Training (EFST) programme during 2025, with 39,000 trainees across food establishments in the emirate completing the training. This brings the cumulative number of beneficiaries since the programme's launch in 2008 to nearly 300,000 trained food handlers, and underscores the programme's pivotal role in enhancing workforce competency and elevating food safety practices across Abu Dhabi's food



ADAFSA organised a stakeholder gathering in December 2025, bringing together representatives from accredited training and examination centres, and the Abu Dhabi Centre for Technical and Vocational Education and Training (ACTVET)

sector.

This mandatory programme is implemented in accordance with Food Law No. (2) of 2008 and Resolution No. (6) of 2020 on food health, which stipulate the requirement to comply with any training programs issued by ADAFSA. The programme serves as one of ADAFSA's key regulatory tools for qualifying personnel across all stages of the food chain. It equips food handlers with essential knowledge and skills to apply best hygiene practices, ensuring food safety and protecting consumer health.

Mohammed bin Rashid issues Decree on Central Grievances Committee for Dubai Government employees

DUBAI / WAM

In his capacity as the Ruler of Dubai, His Highness Sheikh Mohammed bin Rashid Al Maktoum, Vice President and Prime Minister, issued Decree No. (5) of 2026 on the Central Grievances Committee for Dubai Government employees.

The Decree aims to strengthen justice, transparency, and good governance in Dubai's government, while promoting job security and encouraging employee performance and innovation.

The Committee aims to provide employees with the opportunity to appeal final administrative decisions and actions that affect their legal and employment status, roles, and work

conditions, ensuring fairness, impartiality, job satisfaction, and compliance with public service laws and professional conduct standards.

The Decree establishes the Grievance Adjudication Committee to review appeals submitted to the Central Grievances Committee. It includes a Chairman, Deputy Chair, and members with legal and HR expertise, appointed by the Chairman of The Executive Council of Dubai.

The Committee must include representatives from the General Secretariat of The Executive Council, the Supreme Legislative Committee, and the Dubai Government HR Department. The Decree also defines the mandates, duties, and responsibilities of the Grievance Adjudica-

tion Committee, its chairman and members.

Employees may submit grievances within 14 working days from receiving written notice of the Committee's decision, or after the Committee's decision deadline. Late submissions are allowed only with a valid excuse.

Grievances may be submitted to the Central Grievances Committee on grounds such as lack of jurisdiction, violation or misapplication of the law, failure to follow essential procedures, abuse of authority, decisions against the public interest, excessive discipline, or actions taken without a valid reason.

'Edge of Life' campaign raises over AED2.822b before end of Ramadan


