

UAE President receives call from President of the European Council

ABU DHABI / WAM

UAE President His Highness Sheikh Mohamed bin Zayed Al Nahyan received a phone call from His Excellency António Costa, President of the European Council, during which they discussed developments in the region amid ongoing military escalation and its implications for regional and international peace and security, as well as its serious impact on international navigation and the global economy.

The call also addressed the continued Iranian terrorist aggression targeting the UAE and other countries in the region, including attacks on civilians and civilian infrastructure. His Excellency Costa condemned this aggression, noting that it constitutes a violation of sovereignty and international law and undermines regional and international peace and security.

The two sides also discussed cooperation between the UAE, the European Union, and its member states, as well as opportunities to further expand ties in a way that supports shared interests and delivers mutual benefit.

UAE air defences intercept 11 ballistic missiles, 27 UAVs

ABU DHABI / WAM

The UAE air defences on 30th March 2026 intercepted 11 ballistic missiles and 27 UAVs launched from Iran.

Since the start of the blatant Iranian attacks, UAE air defences have engaged 425 ballistic missiles, 15 cruise missiles and 1,941 UAVs.

The attacks resulted in the martyrdom of 2 members of the armed forces while performing their national duty, in addition to the martyrdom of a Moroccan civilian contracted by the Armed Forces, as well as 8 fatalities of Pakistani, Nepali, Bangladeshi, Palestinian and Indian nationalities.

A total of 178 people were also injured, with injuries ranging from minor to moderate and severe. The injured included nationals of the UAE, Egypt, Sudan, Ethiopia, the Philippines, Pakistan, Iran, India, Bangladesh, Sri Lanka, Azerbaijan, Yemen, Uganda, Eritrea, Lebanon, Afghanistan, Bahrain, Comoros, Türkiye, Iraq, Nepal, Nigeria, Oman, Jordan, Palestine, Ghana, Indonesia, Sweden and Tunisia.

The Ministry of Defence affirmed that it remains fully prepared and ready to deal with any threats and will firmly confront anything that aims to undermine the security of the country, in a manner that ensures the protection of its sovereignty, security and stability and safeguards its interests and national capabilities.

The UAE participated in the 14th Ministerial Conference (MC14) of the World Trade Organisation (WTO), held in the capital of Cameroon, Yaoundé.

The UAE delegation was led by Fahad Al Gergawi, Undersecretary of the Ministry of Foreign Trade, and included officials from the Ministry of Foreign Trade, the Ministry of Foreign Affairs, the Central Bank of the United Arab Emirates, and the UAE's representation to the World Trade Organisation in Geneva.




