UAE President His Highness Sheikh Mohamed bin Zayed Al Nahyan on Wednesday held a phone call with Donald Trump, President of the United States of America, during which they discussed

developments in the region and their serious implications for regional and international peace and security, as well as their impact on maritime security and the global economy.

The two sides also discussed the continued Iranian terrorist aggression

targeting the UAE and other countries in the region, including attacks on civilians and civilian infrastructure, noting that it constitutes a violation of sovereignty and international law and undermines regional security and stability.

UAE air defences intercept 5 ballistic missiles, 35 UAVs

ABU DHABI / WAM

The UAE air defences on Wednesday intercepted 5 ballistic missiles and 35 UAVs launched from Iran.

Since the start of the blatant Iranian attacks, UAE air defences have engaged 438 ballistic missiles, 19 cruise missiles and 2,012 UAVs.

The attacks resulted in the martyrdom of 2 members of the armed forces while performing their national duty, in addition to the mar-

tyrdom of a Moroccan civilian contracted by the Armed Forces, as well as 9 fatalities of Pakistani, Nepali, Bangladeshi, Palestinian and Indian nationalities.

A total of 190 people were also injured, with injuries ranging from minor to moderate and severe. The injured included nationals of the UAE, Egypt, Sudan, Ethiopia, the Philippines, Pakistan, Iran, India, Bangladesh, Sri Lanka, Azerbaijan, Yemen, Uganda, Eritrea, Lebanon, Afghanistan, Bahrain, Comoros, Türkiye, Iraq, Nepal, Nigeria, Oman, Jordan, Palestine, Ghana, Indonesia, Sweden and Tunisia.

The Ministry of Defence affirmed that it remains fully prepared and ready to deal with any threats and will firmly confront anything that aims to undermine the security of the country, in a manner that ensures the protection of its sovereignty, security and stability and safeguards its interests and national capabilities.
