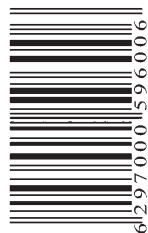

UAE President and Japanese Prime Minister discuss Comprehensive Strategic Partnership and regional developments

UAE President His Highness Sheikh Mohamed bin Zayed Al Nahyan on Tuesday received a phone call from Her Excellency Sanae Takaichi, Prime Minister of Japan, during which they discussed developments in the region and their implications for regional and international security and stability, as well as their serious impact on maritime security, energy supplies, and the global economy.

The two sides also discussed the continued Iranian terrorist attacks targeting the UAE and other countries in the region, including attacks on civilians and civilian infrastructure,

The two sides reviewed UAE-Japan cooperation, particularly in the economic and development fields, noting the progress achieved under the Comprehensive Strategic Partnership between the two countries.

UAE Air Defences engage one ballistic missile, 11 UAVs

ABU DHABI / WAM

The Ministry of Defence announced that on 7th April 2026, UAE air defence systems successfully engaged one ballistic missile and 11 UAVs launched from Iran.

Since the onset of these blatant Iranian attacks, UAE air defences have engaged a total of 520 ballistic missiles, 26 cruise missiles, and 2,221 UAV's.

No martyrs, fatalities, or injuries have been reported in

the past hours.

Since the onset of the blatant Iranian attacks, the total number of martyrs has reached two, in addition to the martyrdom of a Moroccan civilian contracted with the Armed Forces. The total number of civilian fatalities stands at 10, from Pakistani, Nepalese, Bangladeshi, Palestinian, Indian, and Egyptian nationalities.

The total number of injuries has reached 221 since

the onset of the blatant Iranian attacks, involving individuals of various nationalities, including Emirati, Egyptian, Sudanese, Ethiopian, Filipino, Pakistani, Iranian, Indian, Bangladeshi, Sri Lankan, Azerbaijani, Yemeni, Ugandan, Eritrean, Lebanese, Afghan, Bahraini, Comorian, Turkish, Iraqi, Nepalese, Nigerian, Omani, Jordanian, Palestinian, Ghanaian, Indonesian, Swedish, Tunisian, Moroccan, and Russian.

Dragon Oil announces new oil discovery in Gulf of Suez in collaboration with GUPCO

DUBAI /WAM

Dragon Oil, a company fully owned by Emirates National Oil Company (ENOC), in collaboration with the Gulf of Suez Petroleum Company (GUPCO) and the Egyptian General Petroleum Corporation (EGPC), has announced a new oil discovery following the successful drilling of the South El Wasl B.B2 exploration well in the Gulf of Suez, as part of the partnership efforts to enhance exploration activities and increase the production.

Wireline logging data confirmed the presence of an oil-bearing reservoir within the Lower Rudeis formation. The discovery is estimated to add approximately 8 million barrels of original oil in place (STOIP). Initial testing results also indi-



cate production rates above 2,000 barrels of oil per day. The discovery was achieved through the application of ad-

vanced geophysical studies and three-dimensional seismic acquisition utilising Ocean Bottom Node (OBN) technology, which enabled the identification of new structural traps and high-potential exploration targets.
