The United Arab Emirates is closely following the announcement by US President Donald Trump regarding the two-week ceasefire between the United States and Iran, and is seeking further clarification on the agreement's provisions to ensure Iran's full commitment to an immediate cessation of all hostilities in the region and the complete and unconditional reopening of the Strait of Hormuz.

In a statement, the Ministry of Foreign Affairs (MoFA) underscored that the unprovoked Iranian attacks targeting infrastructure, energy facilities, and civilian sites over the past 40 days — which included 2,819 ballistic and cruise missiles, as well as drones — and the resulting loss of life and property damage, necessitate a firm position, including ensuring that Iran is held accountable and fully liable for damages and reparations.

The Ministry emphasised the need for a comprehensive and sustained approach that addresses Iran's full range of threats, including its nuclear capabilities, ballistic missiles, drones, military capabilities, and affiliated proxies and terrorist groups, while ending threats to freedom of navigation, as well as economic warfare and piracy in the Strait of Hormuz.

UAE air defences engage 17 ballistic missiles, 35 UAVs

The Ministry of Defence announced that on Wednesday, 8 April 2026, UAE air defences engaged 17 ballistic missiles and 35 UAVs launched from Iran.

Since the onset of the blatant Iranian attacks, UAE air defences have engaged a total of 537 ballistic missiles, 26 cruise missiles, and 2,256 UAVs.

These attacks resulted in injuries to 3 individuals, all of whom sustained minor injuries, bringing the total number of injuries to 224, involving individuals of various nationalities, including Emirati, Egyptian, Sudanese, Ethiopian, Filipino, Pakistani, Iranian, Indian, Bangladeshi, Sri Lankan, Azerbaijani, Yemeni, Ugandan, Eritrean, Lebanese, Afghan, Bahraini, Comorian, Turkish, Iraqi, Nepalese, Nigerian, Omani, Jordanian, Palestinian, Ghanaian, Indonesian, Swedish, Tunisian, Moroccan, and Russian.

CBUAE, CBB sign AED 20 billion AED/BHD Currency Swap Agreement

The Central Bank of the United Arab Emirates (CBUAE) and the Central Bank of Bahrain (CBB) announced the establishment of a Currency Swap Agreement between the UAE Dirham (AED) and the Bahraini Dinar (BHD) during a virtual signing ceremony. The agreement has a nominal value of AED 20 billion (BHD 2 billion), with a tenor of five years.

The agreement was signed by Khaled Mohamed Balama, Governor of the Central Bank of the UAE and Khalid Humaidan, Governor of the Central Bank of Bahrain. The agreement aims to further strengthen existing financial cooperation between the two nations.
