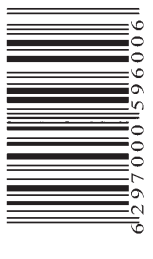

In turn, President Xi Jinping asked H.H. Sheikh Khaled to

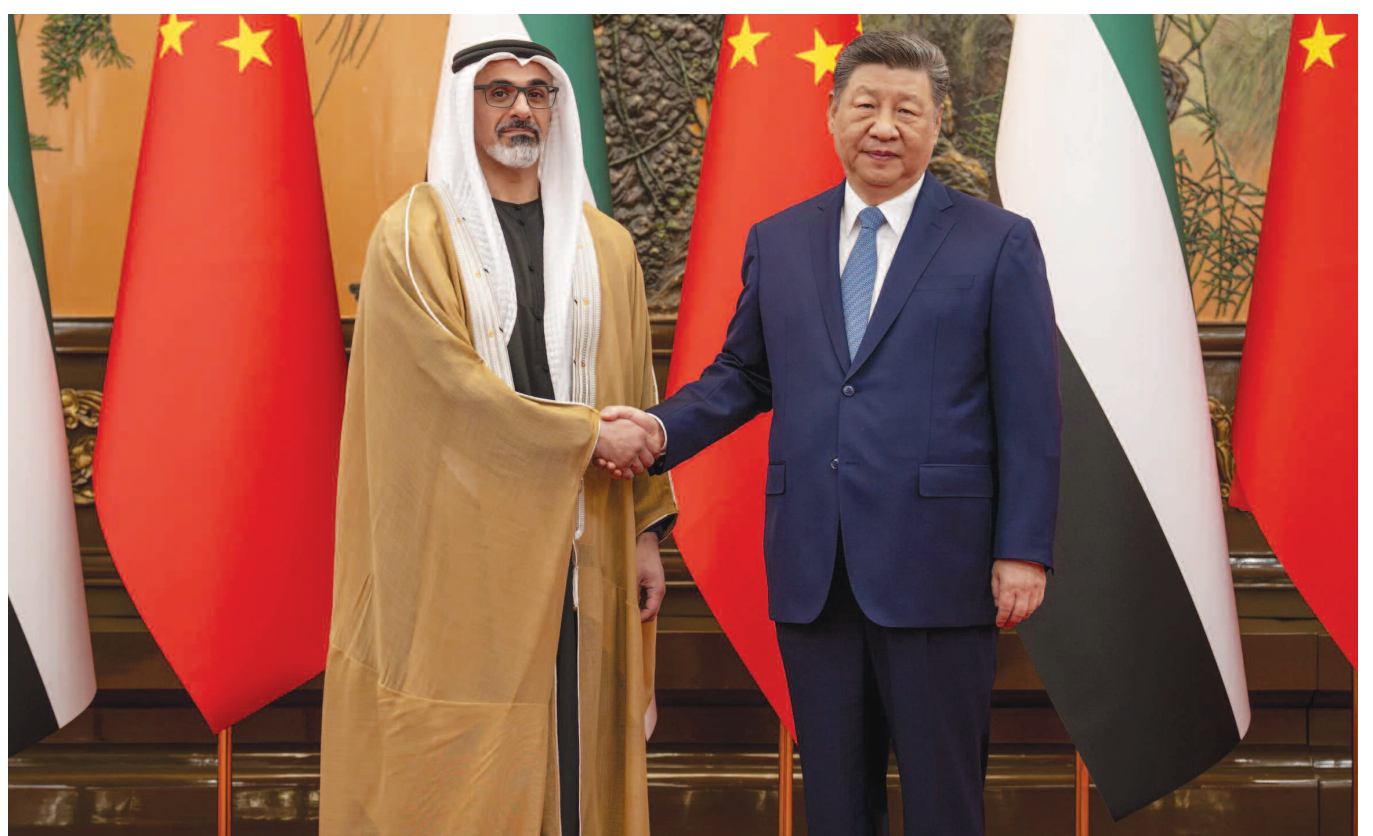
convey his sincere greetings to the President of the UAE, along with his best wishes for the enduring success and development of the UAE and its people.
