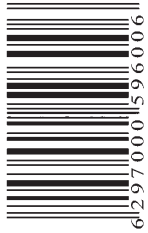

UAE President issues Federal Decree granting Abdulla Ahmed Al Mandous Director of NCM with 'Rank of Minister'

ABU DHABI / WAM

UAE President His Highness Sheikh Mohamed bin Zayed Al Nahyan has issued a Federal Decree granting Dr Abdulla Ahmed Al Mandous the "Rank of Minister".

The Decree shall take effect from the date of its issuance and will be published in the Official Gazette.

Dr Abdulla Ahmed Al Mandous is among the UAE's leading figures in the field of meteorology at both regional and international levels. He currently serves as President of the World Me-

teorological Organisation, in addition to his role as Director of the National Centre of Meteorology (NCM). He has contributed to advancing the meteorological sector in the UAE and strengthening its technical infrastruc-

ture, supporting the accuracy of weather forecasting and enhancing the country's readiness to address climate change. He has also overseen advanced national programmes in rain enhancement science and weather modification.

Dr Abdulla Al Mandous holds a PhD in Meteorology from the University of Belgrade, Republic of Serbia, a Master's degree in Meteorology from the University of the Witwatersrand, South Africa, and a Bachelor's degree in Meteorology from Saint Louis University, United States of America

Mansour bin Zayed, Jordanian PM witness signing of agreement to develop railway network in Jordan, establish UAE-Jordan Railway Company

His Highness Sheikh Mansour bin Zayed Al Nahyan, Vice President, Deputy Prime Minister, and Chairman of the Presidential Court, and Dr. Jafar Hassan, Prime Minister of the Hashemite Kingdom of Jordan, on Wednesday witnessed the signing of an agreement between the UAE and Jordan to develop a railway network in Jordan and establish the UAE-Jordan Railway Company.

The agreement covers the construction and operation of a 360-kilometre railway linking the main mining areas of Al-Shidiya and Ghor Al-Safi to the Port of Aqaba. The project aims to transport 16 million tonnes annually of phosphate and potash, with a total investment value of US\$2.3 billion.

The agreement was signed on behalf of the UAE by Suhail bin Mohamed Al Mazrouei, Minister of Energy and Infrastructure, and on behalf of Jordan by Dr. Nidal Al-

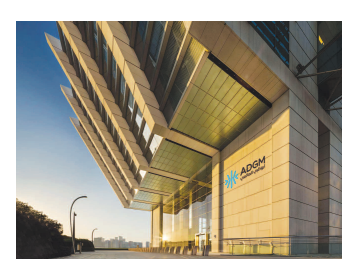

A judgment was issued in the appeal on Tuesday, 24/02/2026, and its operative part reads as follows:
The Court ruled to quash the appealed judgment and ordered the Respondents to pay the court fees and costs, as well as an amount of AED 1,000 (One Thousand Dirhams) as legal fees to the Appellants, and ordered the refund of the security deposit to them. The Court further ruled, in the subject matter of Appeal No. 1357/2025 – Commercial Abu Dhabi, to set aside the appealed judgment in respect of both the main and counterclaims, and to re-adjudicate the main claim by declaring the invalidity of the convening of the General Assembly of the First Appellant (Star Key Hearing LLC) held on 17/07/2025, due to the invalidity of the notice of convening, and the nullity and non-enforceability of all resolutions issued therefrom, and in the counterclaim, it was dismissed. The Court further ordered the Respondents to pay the court fees and costs for both levels of litigation, and an amount of AED 500 as legal fees to the Appellants.
