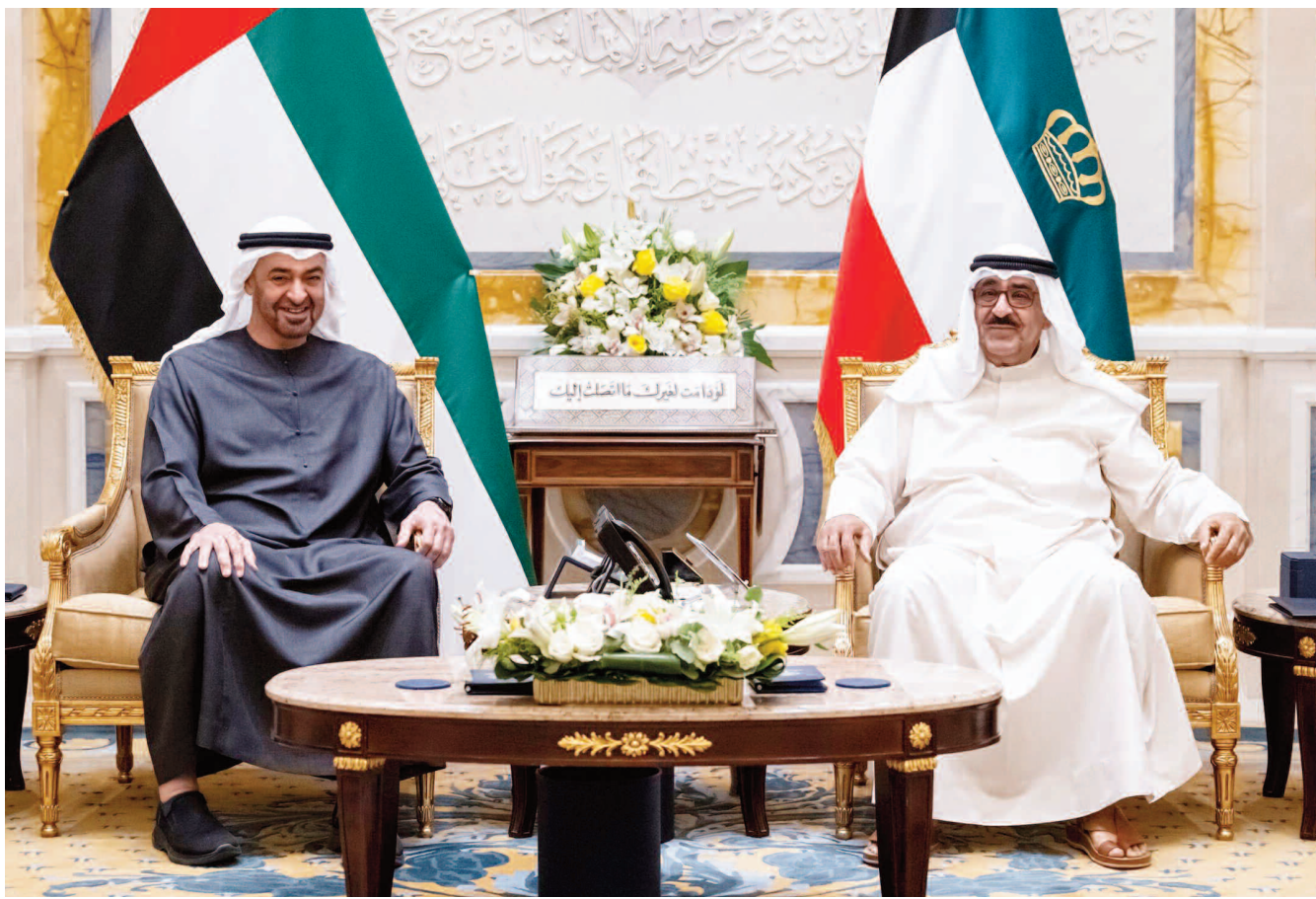

Appeal subject:
Firstly: Accepting the appeal formally as it was filed within the legally prescribed time limit, and permitting the appellant to pay the prescribed fee.
Secondly: On the merits: Ruling in favor of the appellant as follows:
1. Affirming the appealed judgment with respect to its ruling on the termination of the unified sale contract (F) executed on 14/06/2025 concerning the purchase of the hotel apartment No. 5702, Building Five, Jumeirah Village Circle, Dubai, Al Barsha South Four.
2. Alternatively: Appointing a real estate expert whose task shall be to review the case files and what the litigants submit, for the purpose of determining the procedures required to obtain the no-objection certificate from the developer regarding the unit subject to the case, and whether there is an obligation incumbent upon the first respondent against whom the appeal is brought (the Purchaser) imposed by the nature of the sale contract that is the basis of the case, which the first respondent against whom the appeal is brought must fulfill in order for the appellant to obtain the no-objection certificate. And if there is an obligation incumbent upon the first respondent against whom the appeal is brought (the Purchaser), to specify the nature of such obligation and whether the first respondent against whom the appeal is brought must fulfill in order for the appellant to obtain the no-objection certificate from the developer or not, and also to determine the reason why the appellant did not obtain the no-objection certificate from the developer to complete the sale procedures, and which party is in breach thereof. In summary, to determine the party in breach for not completing the procedures for the sale of the unit subject to the dispute, and consequently to determine the appellant's entitlement to her claims.
4. Ordering the first, second, and third respondents against whom the appeal is brought, jointly and severally, to bear the fees, expenses, and attorney's fees for both degrees of litigation.
