UAE President and Sultan of Oman discuss bilateral ties and regional developments in phone call

UAE adopts integrated approach to combat drugs, protect youth

The campaign highlights the vital importance of community solidarity in shielding future generations from the destructive threat of drugs

In recent years, e-cigarettes or vapes have gained notable popularity among youth and teenagers due to their accessibility and aggressive marketing as less harmful alternatives to traditional smoking. However, as vaping spreads among young people, a danger far exceeding the risks of regular smoking has emerged, as drug addiction now creeps in under the guise of e-cigarettes.

Dealers have found devious methods to promote drugs and psychoactive substances through vaping devices; something very difficult for families, educational institutions and regulatory authorities to detect.

Youth and teenagers remain the most vulnerable to these tactics, driven by curiosity, a desire for experimentation, peer pressure and a lack of awareness regarding health and legal consequences.

This susceptibility is worsened by the false belief that vaping is less dangerous than other methods of drug abuse, leaving young people trapped by the seductive marketing strategies used by tobacco and e-cigarette companies across various social media platforms.

To counter these threats, the National Drug Enforcement Authority, in collaboration with the UAE Government Media Office, launched the National Cam-

aign for Drug Enforcement under the theme "United as One to Eradicate the Threat" as part of the UAE's comprehensive strategic vision to protect society and safeguard its national assets, chief among them its youth.

The campaign highlights the vital importance of community solidarity in shielding future generations from the destructive threat of drugs.

Recognising the severity of this emerging method of trafficking, relevant authori-

ties in the UAE have actively pursued dealers targeting teenagers and young adults, resulting in numerous arrests. At the same time, awareness efforts have been intensified to warn the public of these deceptive tactics.

The National Drug Enforcement Authority works diligently, locally and regionally, to crack down on dealers selling drugs through e-cigarettes laced with cannabis oil, and dismantle criminal networks.

The UAE adopted the Na-

tional Anti-Drugs Strategy 2024–2031 in November 2024, aiming to make the nation entirely drug-free by 2031. The strategy aims to realise key national targets, including lowering drug-related mortality rates per million and reducing addiction rates per 100,000 residents.

This national strategy encompasses various programmes and initiatives, including developing community resilience against drugs, advancing research in drug detection methods and supporting vulnerable groups.

It also focuses on establishing safe treatment and rehabilitation centres that enhance quality of life, activating occupational integration mechanisms to lower relapse rates, tightening border controls to stop the influx of drugs, arresting and deterring dealers and engaging in international efforts against drug crimes.

Alongside these security measures, public health entities continue to issue warnings against youth vaping in general, reaffirming that e-cigarettes are just as hazardous as traditional smoking. In fact, many vape users consume higher concentrations of nicotine than they would from regular combustible tobacco products, while added chemical flavourings further accelerate dependency.

TRENDS, partners launch 'Water as a Tool for Peace' policy paper

The event was held as part of the High-Level Political Forum on Sustainable Development (HLPF 2026)

TRENDS Research & Advisory participated in the launch of the United Nations policy paper, Water as a Tool for Peace: Re-assessing Progress and Shaping the 2026 Agenda (Flowing Towards Peace), during a high-level event organised by the UAE Permanent Mission to the United Nations in New York.

The event was held as part of the High-Level Political Forum on Sustainable Development (HLPF 2026) and was attended by UN officials, diplomats, government representatives, research institutions, and international organisations.

The TRENDS delegation included Nasser Mohamed Al Ali, Executive Director of TRENDS Group, and Professor Abdulaziz Al-Shehhi, Senior Researcher and Deputy General Manager of

TRENDS Research & Advisory. They participated in the launch of the policy paper, which represents one of the most significant international research initiatives supporting preparations for the 2026 United Nations Water Conference.

The policy paper is the result of a collaborative international research effort involving TRENDS Research & Advisory, the Geneva Water Hub, and PED-Senegal. It was developed in partnership with UN-Water and the UN Water Convention to support global efforts to strengthen water security and build international consensus ahead of the 2026 UN Water Conference, which will be co-hosted by the UAE and Senegal in Abu Dhabi this December.

The project also received support from the governments of the Swiss Confederation and the



The project also received support from the governments of the Swiss Confederation and the Republic of Slovenia, reflecting the importance of multilateral cooperation in addressing global water challenges —WAM

Republic of Slovenia, reflecting the importance of multilateral cooperation in addressing global water challenges.

During the launch session, Professor Al-Shehhi presented

the paper's key findings and recommendations. He emphasised that threats to global water security extend beyond climate change and natural disasters to include armed con-

flicts, attacks on water resources and infrastructure, and the mismanagement and unsustainable exploitation of water resources. Together, these factors are significantly intensifying the global water crisis.

He explained that the paper calls for fostering sustained international attention to the concept of "water as a tool for peace" by strengthening global cooperation to protect water resources, prevent their use as instruments of conflict or political

pressure, and instead harness them to promote dialogue, build trust, and enhance stability and peace.

Prof. Al-Shehhi noted that TRENDS' participation in this international initiative reflects its ongoing commitment to producing strategic knowledge, supporting evidence-based policymaking, and developing practical solutions to global challenges.
