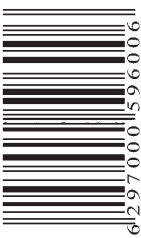

UAE President His Highness Sheikh Mohamed bin Zayed Al Nahyan and Serbian President His Excellency Aleksandar Vučić discussed bilateral cooperation, particularly in the fields of the economy, investment, trade, and renewable energy, as well as other priority sectors, under the Comprehensive Strategic Partnership and Comprehensive Economic Partnership between the UAE and Serbia. The meeting took place during His Highness' working visit to Serbia.

The two leaders reaffirmed their shared commitment to further strengthening UAE-Serbia relations and expanding partnerships that support growth and prosperity for the benefit of both countries and their peoples. His Highness commended His Excellency Vučić's commitment to advancing the strong ties between the two countries.

Healthy Living, in collaboration with the Abu Dhabi Registration Authority (ADRA), the Abu Dhabi Department of Economic Development's (ADDED) arm for regulating and developing the business sector in the emirate, has launched a new

policy redesigning the in-store layouts and online interfaces of supermarkets across Abu Dhabi.

The initiative will ensure that high-fat, salt, and sugar (HFSS) food and beverage (F&B) products are no longer positioned in the highest-traffic, highest-visibility locations



consumers encounter across the emirate.

The new policy will be mandatory for compliance from 1st January 2027. It regulates the placement and promotion of HFSS F&B within physical and online supermarket retail environments, without restricting their sale. The policy was devel-

oped in close collaboration with the Department of Health (DoH), Abu Dhabi Public Health Centre (ADPHC), Abu Dhabi Quality and Conformity Council (ADQCC), and the Abu Dhabi Agriculture and Food Safety Authority (ADAFSA).

Emirates Engineering launches Material Futures Studio

Emirates Engineering has launched Material Futures Studio, a six-week programme that challenges university students to reimagine retired aircraft materials and transform them into new products.

Led by the Upcycling department within Emirates Engineering, the Material Futures Studio brings students together with aviation professionals to work on real-world industry challenges, encouraging fresh thinking while helping develop the next generation of aviation

talent. The first edition brought together 23 students representing Khalifa University, Emirates Aviation University and the University of Sharjah.

The programme began with an orientation and tour of Emirates Engineering's facilities, where students engaged with senior leaders and gained first-hand insight into maintenance operations like A-check and C-checks being carried out on the Emirates fleet as well as the upcycling shop where materials are being repurposed today.

Over the next six weeks, students will use their learnings to
