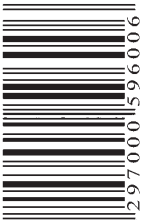

Khaled bin Mohamed bin Zayed chairs first Abu Dhabi Executive Council meeting to use agentic AI platform

HH Sheikh Khaled bin Mohamed bin Zayed Al Nahyan, Crown Prince of Abu Dhabi and Chairman of the Abu Dhabi Executive Council, has chaired the council's meeting, where an agentic AI platform was used for the first time to support analysis-based discussion and data-driven decision making.

Using AI Committee System (an agentic AI platform), the meeting reviewed several public projects and programmes aimed at further enhancing efficiency in government performance and excellence in community

services and public facilities.

His Highness Sheikh Khaled directed the expansion of the Abu Dhabi Liveability Strategy, building on its Phase 1 achievements, which include the completion of more than 60 major projects valued at more than AED12 billion.

The projects were executed as part of a broader approved programme worth AED42 billion, while Abu Dhabi's District Completion Index rose from 67 percent to 84 percent in two years.
