# CBUAE, Central Bank of Egypt renew AED5bn currency swap agreement

The Central Bank of the United Arab Emirates (CBUAE) and the Central Bank of Egypt (CBE) on Tuesday renewed their UAE Dirham (AED)-Egyptian Pound (EGP) currency swap agreement at a signing ceremony held at the CBUAE’s headquarters.

With a nominal value of AED5 billion, equivalent to EGP69 billion, the agreement is valid for five years and underscores the commitment of both central banks to promoting bilateral trade, deepening financial cooperation, and supporting eco-

nomic development in both countries.

The agreement was signed by Khaled Mohamed Balama, Governor of the Central Bank of the UAE, and Hassan Abdalla, Governor of the Central Bank of Egypt.

Both parties reaffirmed their commitment to continuing their joint efforts to deepen financial and banking cooperation, in support of their mutual interests, financial stability, and economic growth in the United Arab Emirates and the Arab Republic of Egypt.

## Etihad Rail begins trial operations ahead of official launch on Sept 30

Etihad Rail has begun trial operations of its passenger train ahead of the official launch of passenger rail services tomorrow, 30th September 2026, as part of efforts to enhance readiness, improve the efficiency of the transport system and provide safe, reliable

The trial operations aim to test the readiness of the stations, trains and journey route, assess the passenger experience, ease of travel and integration with other transport networks, and evaluate various operational procedures before the official service begins.

rector of Commercial and Support at Etihad Rail Mobility, told the Emirates News Agency (WAM) that the Abu Dhabi-Al Yalaisy Station route in Dubai represents an important addition to the national transport system.
